We follow the vessel and cargo operations over the course of an eventful three weeks. It is the Teams discussions within the offices of Integrated Oil and Owners, and the mediation efforts that were made often late into the night, which are the basis for the presentations at this conference.

Conference presentations are in a workshop/case study format which reflect the actual events and discussions that took place between owners, charterers, traders and their brokers. The contractual and commercial issues involved on certain aspects of theses voyages are considered by a panel of international experts reflecting vigorous debates to find the optimal strategy for completing the voyage and delivering the cargo.

Far from being a conference simply for lawyers, this event is designed to be practical, interactive and informative. We will be inviting participants to become a part of these discussions and participate in the commercial negotiations and valuable insights shared.
